## 5. Terms of use

- The applicant shall be liable for all damage to the building and exhibition rooms and for injuries to persons therein caused by it and/or the persons or their agents commissioned to carry out the film or photograph work. This liability shall also apply to accident damage/injury or damage/injury caused by minor negligence. The damage is to be repaired immediately if possible in agreement with MHV. Should this not be possible, the damage shall be repaired by MHV at the expense of the applicant. The applicant shall hold MHV harmless in respect of any damage or accidents, including those relating to third parties.
- All operations on site shall be carried out exclusively in coordination with MHV.
- The MHV museum operation may not be obstructed – or if so, only to the minimum possible extent – by the filming. The film location may be used only in connection with the approved filming.
- The instructions of the MHV attendants shall be followed.
- MHV shall charge the applicant a fee for commercial utilizations.
- The applicant may take photos, film or video recordings only for the purpose and to the extent specified in this application. The applicant may use the photos, film and video recordings only for the said purpose. The utilization right granted to the applicant by MHV may not be transferred to third parties without the written permission of MHV. On termination of the work, the applicant shall provide MHV with a specimen copy of the recordings free of charge.
- Should visitors to Mozarthaus Vienna, its employees or other persons be filmed during the photo shoot, the applicant shall obtain the permission of these persons for the filming or photos. It shall hold MHV harmless in respect of claims by the filmed persons.
- Any modification and/or addition to these terms shall not be valid unless made in writing. Verbal agreements shall be null and void.
